### **Roundtable/Announcements:**

- Lalaida Gee is hosting a Mom's Mixer tonight for parents of African American girls. Mike and Barbara are both attending.

### **Minutes:**

Minutes for the 10/26/15 meeting will be discussed at the next meeting.

### **District Updates:**

Mike is working with a company doing building space analysis for BRMS. The same is being done at other buildings. As Mike hears more, he will share with Council.

### **Growth Data Goals:**

One of the building goals in Reading and Math is that 100% of students demonstrate growth on MAP. Mike shared aggregate growth numbers for last school year. He noted that a large percentage of students are making growth.

### **MAP Testing:**

We are currently administering MAP tests in the fall, winter, and spring. Council discussed whether MAP should continue to be administered in January. At all? For all students? For some students?

### **Homework Club:**

During previous meetings, Council created three potential scenarios for Homework Club. Council members discussed with their constituency groups. The majority of constituency groups voted for the option that makes the opportunity available to any/all students who wish to use it. Rather than learners being "invited", it would be offered primarily at the learner's discretion.

Ross Cohen made a motion to choose Option C. Andrea Leibfried second the motion. Modifications include:

- Open to all students in school, at their prerogative.
- Students will sign up for that day's homework club by the end of Access, perhaps through a Google form.
- Families can be notified electronically that the learner has committed to Homework Club for that day.
- Homework Club will be capped and the Google form will manage that.
- Snacks can be processed based on the attendance for the day and be delivered into the room. This will eliminate time lost due to learners being in the snack line.
- Students will start in room 503. Based upon attendance, some may move with a supervisor to another room.
- Will be held Tuesday, Wednesday, and Thursday for 21 weeks.
- There will be three supervisors.

Ross Cohen amended his motion to include the modifications. Adam Grindle second the amended motion and it passed.

### **Writing Portfolios:**

Council members shared the results of their constituency group discussions about whether we should continue to build writing portfolios and/or continue the end-of-year short interview with each child. Mary Greenlaw-Meyer made a motion to eliminate the formal writing portfolio and interview. Ross Cohen seconded the motion and it passed with one abstention.

### **Parent-Teacher Conferences:**

- 6<sup>th</sup> grade had nearly 100% attendance.
- While it was nice to have met some families previously at parent contact sessions, it didn't have a major effect on parent-teacher conferences (positive or negative).
- Some parents didn't feel a conference was necessary since they had participated in parent contact days.
- Completing conferences with interpreters can be difficult. If anyone gets behind schedule, it affects many.
- Having both an online signup and paper handouts created some confusion. Some families did both.
- The group looking at family involvement/engagement may want to gather this feedback on both conferences and contact days.
- It would be beneficial to have some Access each week where staff can meet with the children on their parent contact day list. There are many ways to expand the meaningfulness, e.g. smaller groups, loop with the kids for three years.
